# Understanding Fees for Aged Care Homes

## BASIC DAILY FEE

Everyone pays this fee, which is currently set at \$65.55 per day. The maximum fee is set at 85% of the single basic age pension. This fee is indexed twice per year in line with the age pension.

## NON CLINICAL CARE CONTRIBUTION & HOTELLING CONTRIBUTION

Depending on your means assessment, your provider may ask you to pay a non clinical care contribution and hotelling contribution. This contribution is different for everyone. The amount you pay depends on your income and assets and your cost of care. Annual and lifetime caps apply to this fee. ## ACCOMMODATION COSTS

You must agree on an accommodation price with your provider before moving into an aged care home. How much of the agreed amount you pay, if any, will depend on your means assessment. If you are eligible for assistance, the Government will pay some or all of your accommodation costs to your provider. If not, you may need to pay the price that you agreed to with your provider.

A lump sum payment is considered an asset for aged care purposes. This means it is counted in your aged care means assessment and may affect your means-tested care fee.

Your provider cannot ask you to commit to an accommodation payment method until you have entered care. You then have 28 days to decide how you will pay. Until you decide, and until you pay a lump sum, you must pay the full daily payment. If you choose to pay by lump sum, you have 6 months after you enter an aged care home to pay the lump sum amount.

## WILL MY FEES CHANGE AFTER I ENTER CARE?

Your fees will not remain fixed after signing a resident agreement. They will change over time. To find out more about fees, including current rates, go to [Understanding costs](#) at [myagedcare.gov.au](http://myagedcare.gov.au).

## WHAT IF MY FINANCIAL CIRCUMSTANCES CHANGE?

A change in your financial circumstances may lead to a change to your means-tested care fee or accommodation contribution. Services Australia will tell you, your nominee (if you have one) and your provider if your fees change. If there is a significant change to your income or assets, you should contact Services Australia on 1800 227 475 and request a review of your fees.

# Understanding Fees for Residential Respite Care

## BOOKING FEE

Your provider may ask you to pay a booking fee to secure a period of respite care in your preferred home. Once you enter the service, your provider will deduct this fee from your daily fees. The booking fee cannot exceed whichever is lower of:

- one week's fee for respite care
- 25% of the fee for the proposed period of respite care

## WHAT HAPPENS TO MY BOOKING FEE IF I CANCEL MY RESPITE CARE BOOKING?

If you cancel more than 7 days before your entry date, your provider will refund your full booking fee.

If you cancel less than 7 days before your entry date, your provider can keep all or part of your booking fee. This does not apply in some circumstances, such as if you're admitted to hospital.

## WHAT IF I CANNOT AFFORD THE FEES?

You may wish to seek independent financial advice before deciding how to pay for aged care. Services Australia's free [Financial Information Service](#) (FIS) can help you understand how aged care costs may affect your finances. To find out more about FIS or to make an appointment, phone 132 300 and say "Financial Information Service" when prompted.

If you cannot pay your aged care fees due to circumstances outside your control, you can apply for financial hardship assistance. You must meet certain eligibility criteria to receive financial hardship assistance and each case is assessed on an individual basis. # Frequently Asked Questions

## WHAT IS A RAD (REFUNDABLE ACCOMMODATION DEPOSIT)?

A RAD is a refundable lump sum accommodation payment. The care recipient may agree the amount of payment with the approved provider prior to or on entry to the service. The care recipient has 28 days to decide on the method for making the payment.

## WHAT IS THE DIFFERENCE BETWEEN A RAD AND A RAC?

The difference between a RAC and a RAD is that a RAC is the term used when a person who is receiving Australian Government assistance with their accommodation costs makes a 'contribution' towards their accommodation costs (with the Australian Government also making a contribution on their behalf).

## ABOUT RAD AND RAC RETENTION

Under the new Aged Care Act, providers will be required to regularly deduct part of each eligible resident's refundable accommodation deposit (RAD) or refundable accommodation contribution (RAC). The amount to be deducted will be calculated daily at a rate of 2% per annum and it will be limited to 5 years to protect residents who remain in care for a long time.

## WHAT IS A DAP (DAILY ACCOMMODATION PAYMENT)?

The Fees and Payments Principles 2014 set out the rules for equivalence between a RAD and a DAP. Section 8 states that an approved provider must ensure equivalence between the RAD and DAP by using the Maximum Permissible Interest Rate (MPIR) applicable on the pricing day.

### As an example:

---

The RAD for a room is

\$575,000.00 The MPIR on the day

is 7.65%

---

The DAP is  $\$575,000 \times 7.65\% / 365 \text{ days} = \$120.51$

## HOW MUCH CAN A CARE RECIPIENT WHO IS PAYING A RAC CONTRIBUTE TO THE COST OF THEIR ACCOMMODATION?

In the example above, if the facility is deemed newly built (NB) or significantly refurbished (SR) the Care Recipient will contribute \$69.79 and the Government co-contribution is zero.

The Care Recipient will co-contribute \$40.65 towards the costs of Accommodation and, because the facility is deemed newly built or significantly refurbished, the Government will contribute up to the \$65.55, therefore  $\$65.55 - \$40.65 = \$24.90$  per day.

## WHAT ARE THE MINIMUM PERMISSIBLE ASSETS A PERSON MUST BE LEFT WITH?

Division 52J-5 of the Living Longer Living Better Act 2013 state that a person must be left with minimum assets after paying an accommodation payment. The minister determines the amount of minimum assets by a legislative instrument. As at 1st November 2025, the amount is \$63,000.00.

## WHAT IS A RAC?

A RAC is a refundable lump sum accommodation contribution. Like the RAD, the amount of the RAC is agreed with the care recipient prior to or on entry to the service. The care recipient has up to 28 days to decide on the method for making the payment.

### As an example:

The Care Recipient has assets of \$210,555.20

---

The Minimum Permissible Assets the Care Recipient is to be left with is \$63,000.00 (as at 1st November)

---

Therefore RAC:  $\$210,555.20 - \$63,000.00 = \$147,555.20$

---

DAC:  $17.5\% \times \$147,555.20 / 364 = \$70.94$

### Another example:

If the Care Recipient has assets of \$147,555.20

---

The Minimum Permissible Assets the Care Recipient is to be left with is \$63,000 as at 1st November 2025.

---

Therefore RAC:  $\$147,555.20 - \$63,000.00 = \$84,555.20$

---

DAC:  $17.5\% \times \$84,555.20 / 364 = \$40.65$

## WHAT DETERMINES THE PAYMENT OF A RAD OR RAC?

Section 52G of the Living Longer, Living Better Act 2013 sets the rules for when an approved provider may legally charge a RAD or a RAC. In summary: If the person's Means Tested Amount is greater than the maximum Accommodation Supplement, the person may legally be charged a RAD.

If the person's Means Tested Amount is lesser than the maximum Accommodation Supplement (\$65.55) as at 1st November 2025 the person may legally be charged a RAC.

## **DO I HAVE TO PAY AN EXTRA SERVICES FEE?**

Belvedere Aged Care is a premium extra services aged care residence. This means that they can provide residents with a higher standard of hotel-type services (including specialised menus, higher quality linen or particular room furnishings). This extra service status applies to the whole home. Some aged care homes with this status can charge a regular extra service fee, which pays for a bundle of extra services. Belvedere Aged Care does not charge an additional extra services fee.

## **WHERE CAN I GET FINANCIAL ADVICE?**

It's beneficial to seek independent financial advice before deciding how to pay for your aged care. Belvedere Aged Care does not provide financial advice. ## **WHAT PERSONAL ITEMS CAN I BRING IN WITH ME?**

Belvedere provides the furniture and furnishings you need, but you can bring your own furniture items, personal items and clothing. To ensure your room is safe and comfortable, speak to us before moving about items you would like to bring in. For OHS purposes, any electrical items brought into the home must adhere testing and tagging requirements.

## **CAN I TAKE SOCIAL LEAVE?**

Residents are entitled to 52 days of social leave in a financial year. Residents can also take extra social leave. However, the Government will not pay the subsidy for those days. To count as social leave, the resident must stay overnight somewhere else such as with family. As an example, a resident can spend every weekend in a year on social leave. # Terminology

## H.E.L.F

HELF, or Higher Everyday Living Fee, is an optional fee in Australian residential aged care that replaces Additional and Extra Service fees. It allows residents to pay for higher-quality services beyond the standard care, such as premium food options, more activities, or additional amenities like pay television or streaming services.

## SINGLE ASSESSMENT SYSTEM

A Single Assessment System (SAS) determines what form of care a person may require.

## ACCOMMODATION PAYMENTS

Accommodation can be paid as a:

- RAD - Refundable Accommodation Deposit (lump-sum payment);
- DAP - Daily Accommodation Payment;
- Combination of RAD and DAP;

Residents will have up to 28 days after entering a facility to decide on their payment method. Accommodation costs will be determined by a resident's assessable income and assets. The prices of rooms are published on the [myagedcare](#) website.

## RETENTION AMOUNTS

Under the new Aged Care Act, providers will be required to regularly deduct part of each eligible resident's refundable accommodation deposit (RAD) or refundable accommodation contribution (RAC). The amount to be deducted will be calculated daily at a rate of 2% per annum and it will be limited to 5 years to protect residents who remain in care for a long time.

## ONGOING CARE FEES

Ongoing Care Fees will include:

- Basic Daily Fee: Payable by All Residents;
- Means-Tested Care Fees: Will be determined by a resident's Assessable income and assets. The maximum daily fee and lifetime caps will apply.
- Higher Everyday Living fee.
- RAC / DAC: Refundable Accommodation Contribution / Daily Accommodation Contribution may be payable by Supported Residents.
- RAD / RAC Retention.

## ASSESSMENT OF THE HOME TO DETERMINE ONGOING CARE FEES

The value of the home will be assessed for the means-tested care fee up to a cap of \$210,555.20, unless occupied by a protected person. A daily cap of \$105.30 will apply to a resident's mean tested contribution to their care costs, together with a lifetime cap of \$135,318.69. These amounts will be indexed.
